Where Does My Water Come From?

New Jersey American Water - Atlantic Division is a public community water system consisting of 23 wells and 1 purchased surface water supply from Atlantic County Municipal Utilities Authority.

This system's source water comes from Atlantic City "800-foot" sand aquifer, Kirkwood-Cohansey water-table aquifer system.

Definitions

- ug/L – micrograms per liter; one microgram per liter is equal to one part per billion (ppb), which is approximately the same as 1 second in 31.7 years

- MCL – Maximum Contaminant Level – the highest level of a contaminant allowed in drinking water under State and Federal regulations
