Definitions

- mg/L milligrams per liter; one milligram per liter is equal to one part per million (ppm),
 which is approximately the same as 1 second in 11.5 days
- μ g/L micrograms per liter; one microgram per liter is equal to one part per billion (ppb), which is approximately the same as 1 second in 31.7 years
- gpg grains per gallon; one grain equals 64.8 milligrams
- ND not detected
- MCL Maximum Contaminant Level the highest level of a contaminant allowed in drinking water under State and Federal regulations
- Secondary MCL are guidelines regulating contaminants that may cause cosmetic effects (such as skin or tooth discoloration) or aesthetic effects (such as taste, odor, or color) in drinking water
