Schedule of Rates – Chicago Metro District Wastewater/Sewer

In accordance with Illinois Commerce Commission regulations, the following rates for wastewater/sewer service have been in effect since January 1, 2017.

General Sanitary Sewage Service

Commercial and Industrial

The rate per 100 gallons, based on water usage, shall be as follows:

First 1,000 gallons	\$0.000000	\$0.000000
Next 1,000 gallons	0.100000	0.510900
Over 2,000 gallons	0.096000	0.495900

The minimum monthly service charge for commercial / industrial customers shall be \$22.00 for Collection Service and \$65.20 for Collection and Treatment Service.

* These charges are applicable to customers in those districts where only collection service is provided at company expense. These districts currently are: Alpine Heights, Chicago Suburban, Country Club, DuPage / Lisle, Fernway, Forest Estates, Moreland, Porter Golf, Rollins, Southwest Suburban (only areas east of Will-Cook Road and North 151st Street), Sunset Manor, Valley View, Waycinden, and West Suburban. To these charges will be added any amounts payable by the company to any public agency for sewage treatment and disposal as set forth in the Purchased Sewage Treatment Surcharge Rider.

General Sanitary Sewage Service (continued)

** These charges are applicable to customers in those districts where waste treatment is provided at the company's investment or expense. These districts currently are: Arbury, Central States, Nettle Creek, Ridgecrest, River Grange, Santa Fe, Southwest Suburban (except areas east of Will-Cook Road and North 151st Street), Terra Cotta, and Valley Marina.

Schedule of Rates and Charges for Purchased Sewage Treatment Surcharge Rider

Country Club Service District Monthly Supply Charge

Residential units individually metered for water service \$89.28

Multiple residential units not individually metered for water service – per residential unit \$75.89

Commercial – rate based on water usage \$2.1488 per 100 gallons

Valley View Service District Monthly Supply Charge

Residential units individually metered for water service \$14.82

Multiple residential units not individually metered for water service – per residential unit \$12.60

Commercial – rate based on water usage \$0.3337 per 100 gallons

Romeoville Wholesale Transportation and Treatment Services Agreement Monthly Supply Charge

Residential, commercial, and industrial – rate based on water usage \$0.6988 per 100 gallons

Rollins Service District Monthly Supply Charge

Residential units individually metered for water service \$25.11

Multiple residential units not individually metered for water service – per residential unit \$18.83

Commercial – rate based on water usage \$0.5623 per 100 gallons

Gross Receipts Tax

A gross receipts charge will be applied to all facilities charges, use charges and public fire protection service charges at the rate of 0.1%.

Illinois CC Assessment

A fixed charge to recover amounts assessed by the Illinois Commerce Commission for its funding at the rate of \$0.03[^] per invoice. Customers receiving both water and wastewater service are assessed the charge only once per invoice.
