

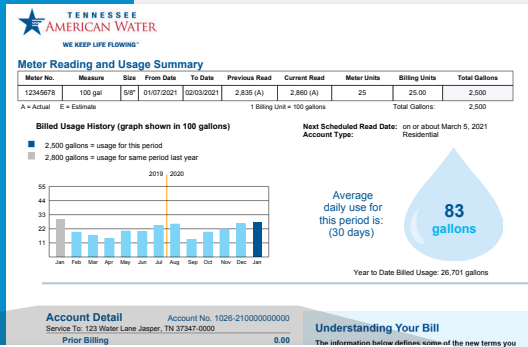

SAMPLE BILL

- 1 Water Service Charge:** Your water service charge is based on your water meter size. This would include your cost for additional gallons beyond the initial 2,500 gallons which is included in the Water Service Charge. This charge applies each billing period, even when there is no water usage.
- 2 Water Usage Charge:** This is your cost for water usage beyond the initial 2,500 gallons in the Water Service Charge. This bill illustrates 0 additional gallons of usage in a billing period.
- 3 Expense Recovery Riders:** The riders are applied to all water charges. The Expense Recovery Rider is based on our actual expenses for items like electricity and chemicals and is compared to what we projected we would spend. The Expense Recovery Riders are based on a percentage of the water service amounts. If we spend less than we budget for, this is a reduction on your bill with the negative sign.
- 4 Capital Recovery Riders:** The riders are applied to all water charges. The Capital Recovery Riders are for improvement projects like new pipes and fire hydrants. The Capital Recovery Riders are based on a percentage of the water service amounts.
- 5 State Sales Tax:** These are the sales taxes applied to the total, at the rate charged by the State of Tennessee.
- 6 County Sales Tax:** These are the sales taxes applied to the total, at the rate charged by Marion County.
