Purpose:

Cal-Am is filing this Advice Letter to update our current Sacramento District Parkway tariff map to bring it into compliance with our actual territory.

Background:

Cal-Am is requesting to update its current Parkway System tariff map on file with the California Public Utilities Commission's Water division to bring into compliance with the actual territory area served by Cal-Am. Per the enclosed correspondence, Cal-Am contacted the City of Sacramento and confirmed that the City of Sacramento's records also show the area at issue is part of Cal-Am's service territory.

No increase to any rate or charge will result from this filing, cause the withdrawal of service nor conflict with other schedules or rules. Cal-Am is requesting that this advice letter filing become effective 30 days after the filing date. Submission of these tariffs is made pursuant to Section 8.1 of the Water Industry Rules in General Order 96-B, and Cal-Am has completed its GIS conversion process for the Parkway System maps. The updated map includes service territory that was shown on Cal-Am's previous update. Also, map layout is updated to show boundaries of the service area, and location of the service area in relation to nearby cities and highways.

Tier Designation:

In accordance with General Order (GO) No. 96B, this advice letter is designated as a Tier 1 filing.

Effective Date:

California American requests an effective date of January 2, 2018.

Service List:

Pursuant to Section 4.3 of General Order No. 96-B, a copy of this advice letter is being sent to those entities listed in the attached "SERVICE LIST PURSUANT TO SECTION 4.3 OF G.O. NO. 96-B." Additionally, following Section 4.2 of General Order No. 96-B (addressing service of advice letters for service area extensions), a copy of this advice letter is being sent to the Local Agency Formation Commission (LAFCO) in the county where the service modification/update is occurring (Sacramento County), on each owner of real property, local fire protection agency, and subdivision permitting agency in the area where service will be modified/updated. In line with Water Industry Rule 4.1(2), a copy of the advice letter is being sent to the water utility serving areas adjacent to the affected service areas. Entities to which this advice letter is being mailed in accordance with Section 4.2 of General Order No. 96-B and with Water Industry Rule 4.1(2) are included in Exhibit A. Copies of the detailed workpapers and the documents supporting this Advice Letter have also been furnished to the Commission Staff.

RESPONSE OR PROTEST¹

Anyone may submit a response or protest for this AL. When submitting a response or protest, please include the utility name and advice letter number in the subject line.

A **response** supports the filing and may contain information that proves useful to the Commission in evaluating the AL. A **protest** objects to the AL in whole or in part and must set forth the specific grounds on which it is based. These grounds² are:

- (1) The utility did not properly serve or give notice of the AL:
- (2) The relief requested in the AL would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
- (3) The analysis, calculations, or data in the AL contain material error or omissions;
- (4) The relief requested in the AL is pending before the Commission in a formal proceeding; or
- (5) The relief requested in the AL requires consideration in a formal hearing, or is otherwise inappropriate for the AL process; or
- (6) The relief requested in the AL is unjust, unreasonable, or discriminatory, provided that such a protest may not be made where it would require relitigating a prior order of the Commission.

A protest may not rely on policy objections to an AL where the relief requested in the AL follows rules or directions established by statute or Commission order applicable to the utility. A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

DWA must receive a response or protest via email (<u>or</u> postal mail) within 20 days of the date the AL is filed. When submitting a response or protest, <u>please include the utility name and advice letter number in the subject line.</u>

Cities and counties that need Board of Supervisors or Board of Commissioners approval to protest should inform DWA, within the 20 day protest period, so that a late filed protest can be entertained. The informing document should include an estimate of the date the proposed protest might be voted on.

REPLIES³

The utility shall reply to each protest and may reply to any response. Any reply must be received by DWA within five business days after the end of the protest period, and shall be served on the same day on each person who filed the protest or response to the AL.

The actions requested in this advice letter are not now the subject of any formal filings with the California Public Utilities Commission, including a formal complaint, nor action in any court of law.

This filing will not cause the withdrawal of service, nor conflict with other schedules or rules.


