PURPOSE:

With this filing California American Water seeks authority to revise the previously approved purchased water offsets in the Los Angeles, Ventura, San Diego, and Larkfield districts to reflect

changes to revenue requirement and authorized production as approved in Decision (D.) 18-12-021.

BACKGROUND:

D.18-12-021, adopting the 2018, 2019, and 2020 revenue requirement for California American Water (CAW), was issued on December 20, 2018. In that Decision the Commission noted that CAW had "filed several advice letters for purchased water offsets, which have been approved by the Commission. We find it reasonable for all costs for the previous GRC cycle to be incorporated into the revenue requirement. 2018 costs should continue to be collected through the purchase water offset surcharge until the next GRC." The revenue requirement adopted in this Decision included within base rates the purchased water cost offsets authorized prior to January 1, 2018 for all districts. Purchased water offsets authorized after January 1, 2018, were not included in the revenue requirement, but were authorized for continued collection through the purchase water offset surcharge. Because CAW combines purchase water offsets into a single surcharge for each ratemaking area it is necessary to revise the purchase water calculation to take out offsetable expenses authorized prior to January 1, 2018 and to adjust the surcharges for the sales estimates authorized in D.18-12-021.

In accordance with Section 7.3.1 of the Water Industry Rules under General Order (GO) 96-B and section 454 of the Public Utilities Code, California American Water is seeking authority to offset Purchased Water Expenses it incurs from the various water wholesalers that supply water to its Los Angeles District, Ventura District, San Diego District, and Larkfield District Service Areas. These various water wholesalers increased rates to California American Water after January 1, 2018. California American Water requests that the full increase be offset in base rates to account for annual change in purchased water cost. Specific revisions by ratemaking district are described below.

REQUEST:

Los Angeles District

Post-January 1, 2018 purchase water offsets for the Los Angeles District were authorized by AL 1206, effective May 14, 2018, and AL 1217, effective November 2, 2018. With this advice letter filing CAW seeks to establish purchase water offset surcharges to continue recovery of these previously authorized expenses. Increase in water rates based on authorized consumption and supply mix results in a \$2,195,304 annual increase in purchased water expense to California American Water, plus a corresponding increase of \$13,110 in uncollectible for a total increase of \$2,208,415 over revenue requirement adopted in D.18-12-021. As discussed above, this change is simply a re-implementation of a previously approved purchase water offset, which is directly related to water consumption and thus should be applied to the quantity rate. The resulting incremental surcharge by service area is as follows:

The offset requested represents an increase of \$2,208,415 or 7.80% over the latest revenue requirement provided and approved by the Commission in AL 1235-A for the Los Angeles District.

Ventura District

Post-January 1, 2018 purchase water offsets for the Ventura District were authorized by AL 1215, with an effective date of October 25, 2018. With this advice letter filing CAW seeks to establish purchase water offset surcharges to continue recovery of these previously authorized expenses. California American Water is requesting an offset due to the Calleguas Municipal Water District increasing water rates from \$1,300 to \$1,375 for Tier -1 rates and \$1,394 to \$1,461 for Tier -2 Rates in 2018. Additionally, the "Capacity Reservation Charge" increased while the "Readiness-to-Serve" charge decreased in 2018. This increase in water rates based on authorized consumption and supply mix results in a \$1,821,743 annual increase in purchased water expense to California American Water, plus a corresponding increase of \$9,365 in uncollectible for a total increase of \$1,831,108 over revenue requirement adopted in D.18-12-021. As discussed above, this change is simply a re-implementation of a previously approved purchase water offset, which is directly related to water consumption and thus should be applied to the quantity rate. This results in a surcharge of \$0.2712 per hundred cubic feet (ccf), or \$0.0363 per 100 gallons. The offset requested represents an increase of \$1,831,108 or 4.80% over the latest revenue requirement provided and approved by the Commission in AL 1232 for the Ventura District.

San Diego District

Post-January 1, 2018 purchase water offsets for the San Diego District were authorized by AL 1212, with an effective date of August, 2018. With this advice letter filing CAW seeks to establish purchase water offset surcharges to continue recovery of these previously authorized expenses. California American Water is requesting an offset due to the City of San Diego's increase of its wholesale water rate from \$4.32 per hundred cubic feet (ccf) to \$4.49 per ccf. This increase in water rates based on authorized consumption and supply mix results in a \$803,922 annual increase in purchased water expense to California American Water, plus a corresponding increase of \$4,133 in uncollectible for a total increase of \$808,055 over revenue requirement adopted in D.18-12-021. As discussed above, this change is simply a reimplementation of a previously approved purchase water offset, which is directly related to water consumption and thus should be applied to the quantity rate. This results in a surcharge of \$0.1780 per hundred cubic feet (ccf), or \$0.0238 per 100 gallons. The offset requested

represents an increase of \$808,055 or 2.55% over the latest revenue requirement provided and approved by the Commission in AL 1233 for the San Diego District.

Larkfield District

Post-January 1, 2018 purchase water offsets for the Larkfield District were authorized by AL 1216, with an effective date of October 25, 2018. With this advice letter filing CAW seeks to establish purchase water offset surcharges to continue recovery of these previously authorized expenses. California American Water is requesting an offset due to the increase in Sonoma County Water Agency wholesale rates from \$1,003.86 to \$1,133.47 per acre-ft. This increase in water rates based on authorized consumption and supply mix results in a \$39,821 annual increase in purchased water expense to California American Water, plus a corresponding increase of \$205 in uncollectible for a total increase of \$40,026 over revenue requirement adopted in D.18-12-021. As discussed above, this change is simply a re-implementation of a previously approved purchase water offset, which is directly related to water consumption and thus should be applied to the quantity rate. This results in a surcharge of \$0.1215 per hundred cubic feet (ccf), or \$0.0162 per 100 gallons. The offset requested represents an increase of \$40,026 or 1.26% over the latest revenue requirement provided and approved by the Commission in AL 1234-A for the Larkfield District.

- 6. The relief requested in the AL is unjust, unreasonable, or discriminatory, providing that such a protest may not be made where is would require relitigating a prior order of the Commission.

A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

The surcharge is \$0.0621 per 100 gallons and will remain effective for 23 months beginning March 31, 2018.
 - b. For the **Duarte** service area, a surcharge is included on each bill to recover the net under-collection in the WRAM and MCBA of \$1,967,409, including interest, as of December 31, 2017. - 7. A surcharge is included in each bill to recover the net under-collection in the Water Revenue Adjustment Mechanism (WRAM) and Modified Cost Balancing Account (MCBA). Per D.18-12-021 the cap on WRAM/MCBA surcharges was raised to 15% of the authorized revenue requirement. For the period ending December 31, 2017, the net under-collection totals \$9,134,703 including interest. The surcharge is \$0.0709 per 100 gallons and will remain effective for 29 months beginning March 31, 2018.
