Purpose:

By this advice letter, California American Water requests authorization to revise its Ventura Rate Schedule and Ventura LIRA Rate Schedule tariffs. The changes are:

- Add the following tariffs:
 - Create new Ventura- 9MC sheets (1-3) to replace sheets (6-9).
- Delete the following tariffs:
 - 2016 GRC Interim Rate True-Up on sheets (4 VN-1 and 8 VN-9MC), which are no longer in effect.
 - Sheets (5 VN-1 and 9 VN-9MC) are being deleted and consolidated with existing sheets (9247-W and 9459-W).
 - Sheets (VN-9MC (6-9), which are no longer effective.
- Modify the following tariffs:
 - Changed "LIRAP" acronym to "LIRA" to be consistent with other tariffs.
 - Changed Purchased Water Offset Special Condition language and rates on sheet (7 VN-9MC) to be consistent with rate sheet (VN-1 9324-W). Tariff

- sheet (7 VN-9MC) was inadvertently not updated with the approved and properly billed rate.
- Updated Ventura LIRA rates to reflect AL 1268, 2020 Step Rates. Tariff sheets (9418-W and 9404-W) were inadvertently not updated with the approved and properly billed rate.

The above changes do not impact authorized rates and all customers were billed correctly with respect to the modification addressed above.

Background:

In an effort to maintain accurate tariffs, California American Water will continuously review its tariffs to identify tariffs that need to be added, deleted and modified.

Request:

California American Water is requesting authorization to update the Ventura Rate Schedule and Venture LIRA Rate Schedule tariffs.

Tier Designation:

These tariffs are submitted pursuant to General Order No.96-B and this advice letter is designated as a Tier 1 filing.

Effective Date:

California American Water requests an effective date of April 15, 2020.

Notice

Per guidance from the California Public Utilities Commission's Water Division, during the COVID-19 pandemic advice letters will only be delivered electronically to the service list. - 4. The relief requested in the AL is pending before the Commission in a formal proceeding; or

- 5. The relief requested in the AL requires consideration in a formal hearing, or is otherwise inappropriate for the AL process; or

- 7. A protest may not rely on policy objections to an AL where the relief requested in the AL follows rules or directions established by statute or Commission order applicable to the utility. A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

Per Advice Letter 1230-B, the under- collected balance in the Ventura County District Consolidated Expense Balancing Account (CEBA) will be recovered through a quantity based surcharge of \$0.0129 per 100 gallons over 12 months effective May 1, 2019. The total amount will be recovered from all classes of customers.
- 6. Per Advice Letter 1282, a surcharge is applied to each bill to offset the increase in purchased water cost imposed by the Calleguas Municipal Water District. The surcharge of \$0.1103 per 100 gallons is set to recover the under-collection at a rate equal to 15% of the authorized revenue requirement as approved by D.18-12-021.
